DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

A Zone Change request to remove the Z (Accessory Dwelling Unit Exclusion) Combining District from a 2.63-acre parcel zoned Land Intensive Agriculture (LIA), located at 9887 Eastside Rd, Healdsburg.

The LIA (Land Intensive Agriculture) Zoning District allows for the use of Accessory Dwelling Units.

EXEMPT STATUS:

The project is categorically exempt under State CEQA Guidelines Section 15305. The project is also exempt from CEQA pursuant to Public Resources Code section 21080.17, adoption of an ordinance by a city or county to implement the provisions of Government Code section 65852.2, regarding permitting of accessory dwelling units.

REASON WHY THIS PROJECT IS EXEMPT:

The project is categorically exempt under State CEQA Guidelines Section 15305 because removing the Z Combining District is a minor alteration in land use limitations in an area with an average slope of less than 20% that does not result in any changes in land use or density because under state law the addition of one accessory dwelling unit may not be considered to exceed the allowable density (Government Code § 65852.2(a)(8)). Adoption of the proposed ordinance is also exempt from CEQA pursuant to Public Resources Code section 21080.17, adoption of an ordinance by a city or county to implement the provisions of Government Code section 65852.2, regarding permitting of accessory dwelling units.

This Notice of Exemption is filed pursuant to the provisions of Section 15062 of the State CEQA Guidelines.
